# **OBJECTS OF THE TRUST**

The objects and purpose for which the Trust is established are:

- a) For the benefit of the citizens of Mercury Bay in particular and of New Zealand in general to promote the advancement and development of arts and culture in the Mercury Bay area and in particular but not by way of limitation;
  - i. To establish, organise, promote and maintain at such intervals as the Trustees may determine an open studio tour on the Coromandel Peninsula
  - ii. To develop awareness of the value of art and artists in the Community
  - iii. To foster and support activities and facilities on the Coromandel Peninsula that will develop community involvement in the arts
  - iv. To provide events and locations for the promotion of Coromandel artists and their works
  - v. To encourage and complement the activities of all Coromandel resources working to assist Coromandel artists
- b) To carry out any one or more of such objects independently of any other such objects

# MISSION

To promote and develop the growth of the visual arts in the Mercury Bay area in particular and the wider Coromandel Peninsula in general.

# ADMINISTRATION

The Trust is governed through a Board of Trustees who meet from time to time to pursue its objects and purpose. A quorum representing a simple majority of trustees is required to conduct a meeting. The Trustees act in a purely voluntary manner and receive no remuneration for services performed.

The Trustees may appoint or replace Trustees provided there are no fewer than five nor more than nine trustees.

All Trustees act in a voluntary capacity but may employ administrative staff from time to time.

The main sources of funding come from Artist members, various grants and Sponsorships

# **CHAIRMAN'S REPORT**

# YEAR ENDED 30 JUNE 2022

# CHAIR'S ANNUAL REPORT - MBAE 2021-2022

Despite continued disruption from the national covid response, planning and preparation for the 2022 Art Escape Open Studios major event including the Showcase Exhibition and Gala Opening proceeded well through the second hand half of 2021 and was effectively complete in January. Targets for funding from major sponsors were achieved and received and approximately 50% of budgeted event expenditure was committed. MBAE continued to have good community support and high regional artist participation and enthusiasm for the future events after the community disruption from covid. Sadly, event restrictions and an assessment of risks associated with community gatherings and travel led to a decision in early February to cancel the March 2022 Art Escape Open Studios and associated events and subsequently attempt to postpone until later in 2022. A poll of participating artists later supported cancellation for 2022, but support of smaller scale local exhibitions through 2022 around holiday weekends where circumstances permitted. Plans were confirmed for the major events in the 2023 programme.

# **2022 Replacement Local Events**

Local events involving artists' studios and group exhibitions were organised by member artists around holiday weekends and were resourced where possible with Art Escape promotional literature, social media marketing, driveway flags and signage to supplement artists' personal investment. Events in Tairua, Hahei, Whenuakite, Hot Water Beach and Whitianga artists elsewhere prompted a very good public response and significant sales.

# Artists' Meeting May 1 2022

A meeting of member artists was held in May to reset current goals and check opinions and support for a revised programme for the balance of 2021-2022 and the 2022-2023 year. About 40% of membership attended and it was a worthwhile gathering to confirm plans and introduce a few new players.

# **Trustee and Management Changes**

Four Trustees including the chairman retired in early 2022 reflecting some impact from covid and disruption to volunteer organisations and four replacements included two previous appointees and a earlier Art Escape curator providing good continuity. A further appointment was made later in 2022 to bring the total to six including two member artists.

A subset of the Trustees and other participating members comprise the Steering Group who manage planning, execution and monitoring of events and membership.

# **Other Highlights**

- The Student Scholarship project with Mercury Bay Area School continued through 2021-2022 and is committed to one scholar per year who joins a senior artist in the community and hands on tuition to supplement their year 13 school year.
- A full programme of social media interaction with the public and within the membership was maintained and refocussed using part time specialist support.
- A Design Brief for a new interactive website to greatly improve artists' window to the public has been approved and contracted for completion before the 2023 event season starts in December 2022. An application for public funding support was made.
- A partnership with new owners of Hot Waves Café in Hot Water Beach will see restoration of a venue for the MBAE 2023 Showcase Exhibition and Gala Opening which is a popular Mercury Bay event.

Lastly, I would like to thank our sponsors and supporters and our member artists, particularly through a very challenging period and recognise the significant contribution from retiring trustees and artist volunteers and acknowledge donors, advertisers, artists elsewhere and our visitor support.

# MERCURY BAY ART ESCAPE TRUST STATEMENT OF ACCOUNTING POLICIES

# 1. Basis of Preparation

Mercury Bay Art Escape Trust has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

# 2. Goods and Services Tax (GST)

The Trust is not registered for GST. Therefore the amounts reported in the Performance Report are inclusive of GST.

# 3. Income Tax

The trust is wholly exempt from New Zealand income tax having fully complied with all statutory obligations for these exemptions.

# 4. Bank Accounts and Cash

Bank accounts in the Statement of Cash Flows comprise cash balances (including short term deposits) with original maturity dates of 90 days or less.

# 5. Specific Accounting Policies Measurement Basis

a) Measurement Basis

The measurement and reporting of results and financial position using the historical cost method has been adopted in the preparation of this performance report.

b) Liabilities

Liabilities are stated at the estimated amounts payable and include liabilities which can be reliably estimated.

c) Accrual Basis

The accrual basis has been applied so as to match income with expenditure in the same accounting period.

There have been no changes in accounting policies during the financial year.
